We reserve the right to refuse acceptance of any dog. Acceptance is based on many criteria, one of which is space availability. We will find the closest, correct foster home or new forever home whichever is first, closest to your area, if possible. If none is found, we might transport to a open foster home that feels comfortable taking in this dog based on the information you have provided.

If the Chin remains in the possession of Releaser until JCCARE is able to place it in a suitable home, it is understood and agreed that the dog is the property of JCCARE, and that neither Releaser nor anyone on his behalf shall take any action on behalf of the animal inconsistent with the JCCARE's ownership. All veterinary care must be pre-approved by JCCARE. As long as the animal remains in the possession of Releaser, Releaser remains responsible for its actions and agrees to hold JCCARE harmless from any claims arising there from.

_____ Releaser acknowledges that the decision to relinquish their Chin is final. The Chin will not be returned to the releaser. We cannot promise updates of the Chin's progress in foster care or in its new home. The releaser will not have contact with the new adoptive family.

_____ Releaser relinquishes the above-described Japanese Chin to JCCARE and warrants that he has the legal right to do so. Releaser holds clear title of this Chin and is free of any other claims. Releaser warrants that this Chin is not under a breeder contract and is not co-owned by any other individual.

_____ Releaser warrants that he has fully and completely disclosed to the JCCARE all information known to Releaser concerning the temperament and behavior characteristics of the animal being released. Releaser warrants that to the best of his knowledge, this animal has never bitten any person, nor shown aggressive behavior toward any person, nor had any serious medical problems unless specified and detailed on attached note and signed off by JCCARE agent and releaser.
